1. Subject: Grants and Programs Update

Recommendation: That the Board receive an oral report on 2nd Story programs and grants:

Alice Villarreal Redit provided update on grants and programs.

- Tools for School: Grant from Union Bank
- Literacy Promotor Program: Grant from Assistance League

The Housing Authority is currently working out details of program.

• Healthy Family Food Distribution: Collaboration with Foodbank

Now have official food distribution site at Presidio Springs. Site is open to the community but predominately serves Housing Authority families but open to community. Recently applied for \$15,000 for commercial refrigerator/freezer as many food items receive are perishable.

• Grace Village Apartments: Grant from Grace Housing, Inc.

Received approval from Grace Housing, Inc. to allocate \$17,000 in funds for startup cost associated with kitchen/dining cost for Gardens on Hope

- Emergency Assistance Fund: Grant from Grace Housing, Inc./In-house program
- Youth Opportunity Fund: Grant from Union Bank/In-house program
- Welcome Home kits: In-house program
- Johnson Court Adopt-a-Room: Grant from Santa Barbara Foundation
- Furnishing Hope: In-house program
- 2. **Subject:** Gardens on Hope Apartments and Johnson Court Studios

Recommendation: That the Board receive an oral report on the status of the construction of Gardens on Hope and Johnson Court Studios

Skip Szymanski reported Gardens on Hope is progressing nicely. All four stories are framed and anticipate completion in February 2020. Johnson Court is fully framed and scheduled to open early 2020.

1. **Subject:** 2nd Story's Admittance as General Partner for 200 North La Cumbre Associates **Recommendation:** That the Board ratify by resolution 2nd Story's admittance as General Partner in the initial partnership for 200 N. La Cumbre Associates, LP

Skip Szymanski stated the Housing Authority purchased a property at 200 N. La Cumbre which is currently a commercial property that will be developed into affordable housing. The Housing Authority forms partnerships to facilitate the development and pre-development process.
